What are Your Rights as the Personal Data Owner (Data Subject)?

Personal data subjects have the rights listed below under Article 11 of the Law "regulating the rights of the data subject":

- Find out if personal data has been processed,
- If the personal data has been processed, to request information about it,
- Find out the purpose of processing personal data and whether they are used for their intended purpose,
- Know about the third parties to whom the personal data has been transferred, in the country or abroad,
- Request correction of personal data in case of incomplete or incorrect processing, and to request notification of the process made within this scope to the third parties to whom the personal data has been transferred,
- Demand that personal data be deleted or destroyed in the event that it is committed in accordance with the provisions of the Law and other applicable laws, and if the reasons for its processing are not met, and to request that the process carried out in this context be notified to third parties,
- Object to the emergence of a result against the person after analysis of the processed data exclusively through automated systems,
- To request compensation for the damage in the event of loss due to the unlawful processing of personal data.

You can submit all your requests regarding the issues listed in the list to MLPCARE in accordance with the Communiqué on Procedures and Principles of the Application to Data Controller.
